<u>Karen Refugee Committee</u> <u>Newsletter & Monthly Report</u> <u>May, 2009</u>

This month on the 1st of May, labourers throughout the world have celebrated (May Day) the worker's day but workers in the camps do not have the right to celebrate the worker's day. For workers in the camps are not considered in the category of the international workers who have the right to enjoy the international labour union law which protects them from selfish and unscrupulous employers. But workers in the camps be they manual/white collar workers working under the NGOs got to work (8) hours a day but are under paid and so far there is no one who will speak out for them that they are being exploited.

At present the situation inside Burma relating to the refugee camps along the Thailand-Burma border, the SPDC has changed it's administrative method over its alliances DKBA and other groups and are joining hands with them to fight against all the outpost of other factions along the border who are opposing them. On account of such repercussion induces people to escape the fighting by crossing over to Thai soil for safety. Some even entered the camps and settled down without permission. The objective of the SPDC offensive according to some observer is to console the international community that all dissidents and opposing groups are crushed and that the 2010 election shall be carried out as planned without hindrances. On the other hand the KNLA splinter group with the help of the SPDC will make arrangement for the repatriation of the refugees and hinting of trying to get international support which is causing must unrest in the camp. At the same time at one of the camps a chemical powder was discovered and could not be determined whether it was connected to the present situation along the border.

Because of the "Pin long" Agreement of 12th February 1947, Burma gained independence from the British in January 4th 1948 but until now it is still under the rule of military Dictatorship. Self rule under democratic system of the Union Government of Burma could be maintained from 1948 to 1962 a period of only 14 years a non military rule. Since 1962 to 2009 a period of exactly 47 year is under the repressive military rule.

According to the "Pin Long" agreement there is a clause stating the ethnic nationalities have the right to secede from the Union after 10 year since independences in 1948. Most observers had conceded that not wanting to honour the said clause of the "Right to secede" Ne Win and his military henchmen took over power proclaiming itself Military Council Government.

Claiming that the military (Tatmadaw) for the good of the country and in a bid to protect the country from disintegration had to take over power.

And now the military government in an attempt to gain international support and adopt a democratic system of government will be holding a democratic election in the year 2010 according to the will of the people. Many are waiting and watching whether it will be a truly free and fair election. While the civil war is still raging the democratic movement is going on and many human rights activists are still under detention. We still have to wait and see what the election result will be.

Regarding the situation of the camps since last two months, cases have been happening constantly. The people in the camps seem to be living in a separate world for quite some time and are suffering from psychological effect which prompts them to cause problem. More over, living in a community comprises of many nationalities, with different language, belief, creed and code can stir up problem. According to last month's report in a camp of 18,000 people there were (24) cases relating to drunkenness, (11) cases of household violence, (2) cases of illicit drugs, (4) cases of forest destruction. In other camps cases such as killing, rape, striking with chopper have occurred intermittently.

We are grateful for receiving support from donors until now, but on the other hand considering the increase of camp population (high childbirth rate), economic recession, world wide, we fear that the helping hand of donors might lessen.

After all, the refugees are victims of conflict and confrontation. Though they are yearning for the word peace, they have no power to make it becomes true. By waiting day by day upon those who could probably make it become true, they have been waiting in the camp for three generations already.

We the KRC with great hope for genuine internal peace based on equality and the emergence of democracy are expecting to lead our refugees from the camps back to our own country when peace and order are restored.
